Dr. Ruth Cowart Wright was born January 26, 1929, in Lubbock, Texas. She graduated from Lubbock High School and went on to complete her education at Texas Tech University and American University. She began her career in academics as a teacher in the public schools of Slaton and Lubbock before going on to join the political science department faculty at Texas Tech in 1957, where she taught until her retirement. She married Elmer Wright in 1964. Ruth authored numerous articles in the field of American government and was the co-author of an early text on Texas government and politics. She was known by her friends for her keen observations on life, her wit, good humor, and most especially, for her love of animals.

Who is eligible?

Grantmaking policy and grant award decisions are made by the Board of Directors. Support from the Ruth C. Wright Endowment for Animals is restricted to organizations in the South Plains area that are 501(c)(3) or the government equivalent. Grants may be made for start-up funding, general operating support, program support, equipment and facilities, emergency needs and demonstration programs. The Foundation does not make grants to individuals, for political purposes, to retire indebtedness or for payment of interest or taxes. All grant recipients must report on the expenditure of grant funds and results of the supported project within one year of the award.

The Process

The Lubbock Area Foundation accepts proposals for grants from the Ruth C. Wright Endowment for Animals on December 1st of each year. After we receive your complete proposal, copies will be provided to the Grants Committee who will make its recommendations to the Board of Directors. Additional information or a site visit may be requested. You will be notified of the Board's decision as soon as possible after the Board meeting at which your application is considered.

To Apply

Application deadline is December 1st of each year. If the 1st happens to fall on a weekend or a holiday, proposals are accepted on the first working day following the due date.

The proposal packet should include a completed Proposal Summary form (online at www.lubbockareafoundation.org/grant.shtml) along with the attachments listed below and ten (10) copies of the narrative and project budget sections. DO NOT submit ten copies of all attachments – only the narrative and project budget sections. Proposals should be mailed or delivered to the following address:

Narrative & Project Budget

- Description of the project and the need addressed.
- Specific use of funds requested.
- A brief statement of the capability of personnel responsible for project implementation.
- List of grants received/pending related to the project and plans for additional funding.
- A plan for evaluation of project success.
- Plans for project continuation.
- Detailed project budget

Attachments

- Proof of tax-exempt status — 501(c)(3) or equivalent.
- A detailed copy of the organization's current annual operating budget.
- A copy of the most recent audit (if no audit current financial statement).
- A current listing of the Board of Directors.
- A resolution from the Board approving the application.
